Even though for one semester in the 2020/2021 school year learning activities are still carried out online in the network (online), even though in the implementation of education it is still being held online, some students say that things like racism, discrimination seem unlikely that this will happen at SMK Nusantara 2 Kesehatan. [21] This is indeed a form of the importance of human rights values in the implementation of education at SMK Nusantara 2 Kesehatan, so if these human rights values are deemed not important it has the potential to create an imbalance between students in the process of administering education.
